I. Scope

A policy on preservation of Documents (defined below) would ensure safekeeping of the records and safeguard the documents from getting manhandled, while at the same time avoiding superfluous inventory of documents. The Company, therefore, formulates this policy, in pursuance to Regulation 9 & 30 (8) of the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Regulations”), on preservation of the documents to aid the employees in handling the documents efficiently. It not only covers the various aspects on preservation of the documents, but also the safe disposal / destruction of the documents.

2. Definitions –

- 2.1 “Act” means the Companies Act, 2013.
- 2.2 “Applicable Laws” means any law, rules, circulars, guidelines or standards issued by Securities Exchange Board of India, Ministry of Corporate Affairs and The Institute of Company Secretaries of India under which the preservation of the documents has been prescribed.
- 2.3 “Authorized Person” means Company Secretary of the Company or any person duly authorized by the Managing Director.
- 2.4 “Board” means the Board of Directors of the Company or its Committee.
“Company” means SAURASHTRA CEMENT LIMITED.
- 2.5 “Current Documents” means any document, that still has an ongoing relevance with reference to any ongoing litigation, proceedings, complaint, dispute, contract or any like matter.
- 2.6 “Document(s)” refers to papers, notes, agreements, notices, advertisements, requisitions, orders, declarations, forms, correspondence, minutes, indices, registers and or any other record, required under or in order to comply with the requirements of any Applicable Law, whether issued, sent, received or kept in pursuance of the Act or under any other law for the time being in force or otherwise, maintained on paper or in Electronic Form and does not include multiple or identical copies.
- 2.7 “Electronic Records(s)” means the electronic record as defined under clause (t) of sub-section (1) of section 2 of the Information Technology Act, 2000.
- 2.8 “Electronic Form” means any contemporaneous electronic device such as computer, laptop, compact disc, floppy disc, space on electronic cloud, or any other form of storage and retrieval device, considered feasible, whether the same is in possession or control of the Company or otherwise the company has control over access to it.
- 2.9 “Maintenance” means keeping Documents, either physically or in Electronic Form.
- 2.10 “Preservation” means to keep in good order and to prevent from being altered, damaged or destroyed.
- 2.11 “Regulations” mean the Securities Exchange Board of India (Listing Obligation and Disclosure Requirements) Regulations, 2015.

The words and phrased used in this Policy and not defined here shall derive their means from Applicable Law.

3. Coverage

This Policy is intended to guide the Company and its officers on maintenance of any documents, their preservation and disposal.

4. Classification

The preservation of documents shall be done in the following manner:

- (a) Where there is a period for which a document is required to be preserved as per Applicable Law, for the period required by Applicable Law.
- (b) Where there is no such requirement as per Applicable Law, then for such period as the document pertains to a matter, which is “Current”.
- (c) In case of any other document, for such period, as a competent officer of the Company required to handle or deal with the document takes a considered view about its relevance; Provided that generally speaking, a document may be preserved for a period of 5 years from the date on which the document was originated.

➤ **An indicative list of the documents and the time frame of their preservation is provided in Annexure – 1.**

5. Modes of preservation

- 5.1 The documents may be preserved in
 - i) Physical form or
 - ii) Electronic form.

An index of documents preserved (in the chronological order as per date) should be maintained by the Authorised Person (as per format at **Annexure – 2**)

- 5.2 The officer of the Company required to preserve the document shall be Authorized Person who is generally expected to observe the compliance of requirements of Applicable Law.
- 5.3 The preservation of documents should be such as to ensure that there is no tampering, alteration, destruction or anything, which endangers the content, authenticity, utility or accessibility of the documents.
- 5.4 The preserved documents must be accessible at all reasonable times. Access may be controlled by Authorized Person with preservation, so as to ensure integrity of the documents and prohibit unauthorized access.

6. Custody of the Documents.

Subject to the Applicable Law, the custody of the Documents shall be with the Authorized Person. Whether the Authorized Person tenders resignation or is transferred from one location of the Company to another, such Person shall hand over all the relevant documents, lock and key, access control or password, or company disc, other storage devices or such other documents and devices in his possession under the policy to such other Authorized person as may be decided by the Managing Director / Board.

7. Authority for approval of Policy

The Managing Director of the Company as authorized by the Board shall have the authority for approval of this policy in pursuance to the Regulations.

8. Authority to make alterations to the Policy

The Managing Director is authorized by the Board to make such alterations to this Policy as considered appropriate, subject, however, the condition that such alterations shall be in consonance with the provisions of the Acts and Regulations. Any changes made in the policy should be ratified at the forthcoming Board Meeting.

9. Conversion of the form in which the documents are preserved

9.1 The physical documents preserved may be converted, whenever required or felt necessary, into electronic form to ensure ease in maintenance of records and efficient utilization of space.

9.2 This will be done after obtaining prior approval of the Managing Director.

10. Authenticity

Where a document is being maintained both in physical form and in Electronic form, the authenticity with reference to the physical form should be considered for every purpose.

11. Interpretation

In any circumstance where the terms of this policy differ from any existing or newly enacted law, rule, Regulation or standard governing the Company, the law, rule, Regulation or standard will take precedence over these policies and procedures until such time as this policy is changed to conform to the law, rule, Regulation or standard.

- Memorandum and Articles of Association.
- Shareholding Pattern.
- Quarterly Financial Results.
- Annual Financial Results
- Annual Report.
- Shareholding Pattern in case of Capital Restructuring.
- Voting results by Shareholders.
- Quarterly disclosures to the Stock Exchanges.
- Yearly disclosure of shareholding of Promoters.
- Minutes of Board / Committee meetings.
- Minutes of General Meetings.
- Register of Charges.
- Register & Index of Members
- Registered of renewed and duplicate share certificates.
- Register of Contracts in which Directors are interested.
- Register of Directors, Managing Director, Manager & Company Secretary.
- Register of inter-corporate deposits, loans and investments.
- Register of deposits.
- Register of Payment of dividend.
- Register of Director's attendance.

Preservation of documents for 8 years in Physical/Electronic Mode:

- Statement under Grievance Redressal Mechanism.
- Corporate Governance Report.
- Compliance Certificate to the exchange about the share related activities maintained by RTA registered with SEBI.
- Compliance Certificate w.r.t. Transfer or Transmission or transposition of securities within 30 days.
- Listing Fees.
- In-principle approval prior to issue of securities.
- Prior intimations of Board meeting for financial results.
- Disclosure of Price Sensitive Information.
- Shareholding Pattern prior to listing of securities.
- Record date or Date of closure of transfer books.
- Record date for declaring dividend and / or bonus.
- Disclosure of Events or Information
- Disclosures under Code of Internal Procedures and Conduct for Regulating, Monitoring and Reporting of Trading by Insiders.
- Register of Charges
- Register of debenture holders or any other security holders
- Copies of all annual returns prepared under Section 92 of the Companies Act, 2013 and copies of all certificates and documents required to be annexed thereto.
- All notices pertaining to disclosure of interest of directors.
- Office copies of Notices, scrutinizer's report and related papers.

Preservation / Archival of documents for 5 years in Physical / Electronic Mode:

- All the information / disclosures of material events as disclosed by the Company to the Stock Exchanges under Regulation 30 of (SEBI Listing Regulations).
